Preparatory Conference for the 2021 Peacekeeping Ministerial Organized by the Islamic Republic of Pakistan and the Kingdom of the Netherlands

Safety and Security & Protection

**25 and 26 October 2021
8-11AM EDT**

In advance of the December 2021 UN Peacekeeping Ministerial in Seoul, Republic of Korea, the Islamic Republic of Pakistan and the Kingdom of the Netherlands are organizing a preparatory conference on Safety and Security and Protection. The preparatory conference seeks to further the Action for Peacekeeping+ (A4P+) agenda by focusing on the importance of training and capacity building, health and medical support, mission integration, technology and community engagement¹.

In recent years, not in the least through the Secretary General's Action for Peacekeeping initiative, progress has been made on improving the safety and security of peacekeepers and protection of civilians. Efforts have been made to address deficiencies in the field of: training, capacity, leadership (at all levels), performance and accountability, medical capacities, equipment and other resources.

Goals:

- Examine how to meaningfully enhance safety and security of peacekeepers, as well as the protection of civilians.
- Lay the foundation for - and encourage - meaningful pledges on these topics for the 2021 Peacekeeping Ministerial.

Safety and Security

The operating environment for peacekeepers remains volatile with evolving threats to peace and security. Peacekeepers are deployed in deteriorating and complex political and security environments, face asymmetrical threats, and have increasingly become a target. As the challenges mount, we must commit ever stronger to the safety and security of UN peacekeepers. Efforts are needed to further enhance the protection of peacekeepers and promote it as a shared endeavor in accordance with A4P+.

Providing a safe and secure environment for all blue helmets requires a continuous adaptation of the capabilities and capacities of UN peacekeeping operations. By increasing the safety and security of peacekeepers, they will be better able to deliver on their mandates, including the protection of civilians.

Protection of Civilians

Protecting civilians is a fundamental mandated task within most peacekeeping missions.

Protection responsibilities are, however, intrinsically linked to other mandated tasks, including, support to peace processes, promotion and protection of human rights, building rule of law and security institutions, and facilitating the delivery of humanitarian assistance.

In the area of protection advancements have recently been made. There is for example increased attention to the importance of context-specific (pre)deployment training. There remains room for improvement to ensure that each mission has a tailored approach to protection that is, amongst others, based on a solid understanding of protection mandates and responsibilities, as well as indicators of, and responses to, sexual violence in conflict.

Participation: The preparatory conference is intended for senior national experts on peacekeeping, peacebuilding, and sustaining peace. We welcome civilian and military participation from capital and New York, with a maximum of 10 participants per delegation. All participants are encouraged to come to the preparatory meeting prepared to identify and develop deliverables related to safety and security, as well as, protection of civilians.

On both days, there will be a plenary opening session, followed by three simultaneous break-out sessions, and a plenary session to conclude. Participants will be provided with the opportunity to register for break-out sessions beforehand. The conference will be in English.

- ❖ *Session 1: Peacekeeping Training and Capacity Building for PoC and Safety and Security*

- The effective development and execution of training and capacity building is a critical element to ensure that peacekeepers are adequately trained and fully equipped to ensure their own safety and security, as well as, for them to be able to exercise their mandates in the area of PoC.

 - What training and capacity gaps exist in relation to safety and security and PoC?
 - What needs to be done to ensure all peacekeepers receive proper pre-deployment training on safety and security and PoC?
 - How can integrated scenario-based exercises in pre-deployment training be expanded and improved?

- ❖ *Session 2: Health and medical support*

- Basic medical preparedness, casualty and medical evacuation and the provision of medical and hospital coverage at all levels are fundamental to the safety and security of UN peacekeepers. Building on recent improvements and policy changes, it is urgent to provide adequate medical support, including along the full CASEVAC chain, as to reduce casualties and deaths of peacekeepers in peacekeeping missions. Other important priorities include: preventing and treating diseases, including COVID-19 and endemic infectious diseases, and the provision of mental health support.

❖ *Session 3: Operational integration*

- In line with Action for Peacekeeping +, better integration of mission components would improve, amongst others, delivery on political goals, protection efforts as well as efforts to strengthen the safety and security of peacekeepers, and engagement with partners. Operational integration needs to be enhanced to achieve unity of purpose for greater impact. Ideally, integrated assessment and planning steers all peacekeeping operations.

 - With the aim to enhance integration, how can the following be improved: integrated assessment, planning, mandate implementation, and reporting between uniformed, civilian and support units?
 - Can you share lessons learned regarding joint planning; what are necessary enablers?
 - How can Member States contribute to more effective operational integration?

- ❖ *Session 1: Technology for Safety and Security of peacekeepers and Protection of Civilians*
 - Technology has become more important as UN missions expand into complex environments facing multiple threats. It is vital for the protection of civilians and safety of UN-peacekeepers and a cross-cutting theme of the Ministerial. Technology can enhance the situational awareness and overall capabilities of the mission and can assist peacekeepers at the individual, unit/section, component and mission levels.
 - Guiding questions:
 - How can we improve solid data collection, data management and data-driven decision-making in missions? What is needed to ensure missions fully utilize existing information systems?
 - How can we strengthen IED threat mitigation and responses, as well as, provide missions with consistent and adequate C-IED/combat convoy capabilities?
 - How can we use technology to improve force protection, specifically integrated camp and convoy protection? What role can partnerships play?
 - How can we ensure a responsible use of technology?

❖ *Session 2: Performance for PoC*

- Performance and accountability mechanisms in the area of protection increase institutional and individual responsibility and awareness, while strengthening the protection of civilians and enhancing the legitimacy and effectiveness of peacekeeping missions.
- Guiding questions:
 - What can TCC's and PCC's do to improve performance on PoC; e.g. by increasing accountability of commanding officers for performance through better posture, monitoring and corrective actions and incentives?
 - How can accountability mechanisms further enhance peacekeeping's mission in the area of PoC?
 - How can we improve evaluation practices and strategic partnerships between TCC's/PCC's and the Secretariat to strengthen performance and accountability for PoC?
 - What resources are required to enhance performance?

❖ *Session 3: Community Engagement*
